Master's degree in State Law from the University of São Paulo (USP), with dissertation entitled The Mutability of Administrative Contracts, in 1994, and degree in Administrative and Financial Political Law, at the same University, in 1987. Practiced the law profession for many years in São Paulo, Brazil and Guinea-Bissau. Teacher and holder of the discipline of Administrative Law II, at the Faculty of Law of Bissau, from 1995 to 1997.
