She is a Ph.D candidate in Information Sciences and Technologies at ISCTE- University Institute of Lisbon. Her research interests are advanced analytics for finance and accounting, earnings management, european Union funds, data quality and information systems.

She is a research assistant at ISTAR-Information Sciences, Technologies and Architecture Research Center. She is involved in scientific projects that are related with machine learning applications to improve the management of european union funds, with emphasis on "IA-Incentivos - artificial intelligence in incentive management" and "MAIPRO - project non-compliance monitoring and alert".
