

His Master dissertation was titled: "Europeanization in Portugal: nuclear non-proliferation and disarmament". He also completed two specialization seminars in the later institution: "The Idea of Europe: from the Lisbon Earthquake to the Lisbon Treaty" and "The Middle East in World Politics".

He is currently a research assistant for the Center for International Studies, and holds a scientific research scholarship from the University's Ph.D. program.
