I am a Researcher and Investigator on an internship project within the department Centro de Investigação e Estudos de Sociologia (CIES-IUL) in ISCTE University Institute of Lisbon, Portugal. The research and internship project is on Equal Pay and its regulation via a comparative studies in Portugal in the context of the workplace via examination of the sociology public policy approach of the issues of Equal Pay. While conducting research and internship projects I am also conducting peer review of journal article publications and part of the working research committee in Oñati International Institute for the Sociology of Law, Spain.

In the UK, I am a Senior Graduate Teaching Assistant in Warwick's School of Law, the University of Warwick is ranked within the top 10 Universities in the country and has world class status.
